## **Nursing (BSN, ABSN)**

The Traditional Prelicensure Bachelor of Science in Nursing (BSN) and the Second Degree Prelicensure Accelerated Bachelor of Science in Nursing (ABSN) programs at Mercer University are designed to prepare students for licensure in the state of Georgia, and the educational requirements to obtain licensure outside of Georgia vary. Most states approve nursing degrees from accredited programs. The Bachelor of Science in Nursing programs at Mercer University are accredited by the Commission on Collegiate Nursing Education, 655 K Street NW, Suite 750, Washington, DC 20001, (202) 887-6791 and approved by the Georgia Board of Nursing. Students who complete the BSN (Traditional or Accelerated track) are eligible to take the National Council Licensure Examination (NCLEX-RN) for licensure in Georgia.

The table below displays where the programs meet or do not meet the educational requirements for initial licensure (also known as Licensure by Examination) or where Mercer has not been able to determine if the programs meet the state or territory requirements. In some states where the programs meet the educational requirements, there are additional conditions that must be met (*e.g.*, a non-credit online course in recognizing child abuse). In several states, the BSN program meets requirements while the Accelerated BSN does not. Each state board has the ultimate authority and discretion to determine whether professional licensure will be issued. Students are encouraged to contact the board of nursing in the state in which they intend to practice before enrolling in the program.

A graduate interested in practicing in one of the states listed as **No** may wish to explore the options available under the <u>Nurse Licensure</u> <u>Compact</u> or the more generic Licensure by Endorsement path, both of which require an existing license in the state of Georgia.
