## Family Therapy (MFT)

The requirements for professional licensure as a marriage and family therapist are met when an applicant has a graduate degree in marriage and family therapy or related discipline from an accredited institution, as recognized by the Department of Education, and satisfies requirements related to education, experience, supervision, and examination. Many states also require the master's program to have professional accreditation. In addition to Mercer's <u>institutional accreditation</u>, the Master of Family Therapy (MFT) program is accredited by the <u>Commission on Accreditation for Marriage and Family Therapy Education (COAMFTE)</u>.

All states and territories have other licensure requirements, such as passage of the MFT national exam, specific coursework and credit hours, clinical practice and supervision experience, state-specific jurisprudence exams, applications, fees, and background checks. Each state licensing board, agency, and/or department has the ultimate authority and discretion to determine whether professional licensure or certification will be issued in that state.

Below is a table that displays states where the MFT program meets, does not meet, or Mercer is unable to determine if it meets educational requirements for licensure. Please review the table closely to determine if the MFT program meets the educational requirements in the state in which you reside or intend to seek licensure.
