## **Physical Therapy (DPT)**

The educational requirements to obtain licensure as a physical therapist are met when a student earns a degree from an accredited program in physical therapy. Mercer's Doctor of Physical Therapy (DPT) program is accredited by the <u>Commission on Accreditation in</u> <u>Physical Therapy (CAPTE)</u>, 1111 North Fairfax Street, Alexandria, Virginia, 22314.

There are many other requirements to obtain licensure as a physical therapist. All applicants must successfully pass the National Physical Therapy Exam (NPTE). Other requirements may include specific clinical practice experience, state-specific jurisprudence exams, applications, fees, background checks, etc. Each state board, agency, or department has the ultimate authority and discretion to determine whether professional licensure or certification will be issued.

Please review the table closely to determine if the DPT program meets the educational requirements in the state in which you reside or intend to seek licensure.
